Having considered Class Counsel's Application for Approval of Distribution Formula and Distribution Awards for all eligible claimants; all other documents submitted in connection with the Application, including the Declaration of Mara R. Thompson and Exhibits 1-6 attached

1 thereto (Exhibits 2, 3, 4 and 5 are maintained under seal to protect claimant and award
2 confidentiality); the record of this case; and the memoranda and arguments of counsel;

3 It is hereby ordered that the Class Counsel's Application for Approval of the Distribution
4 Formula and Distribution of Awards to eligible claimants is hereby GRANTED.

5 The Court makes the following findings and rulings:

6 1. Class Counsel's proposed Distribution Formula for allocating the Claims Portion
7 of the Fund among eligible claimants is fair, reasonable and adequate and is hereby approved for
8 use in determining the allocation of the Claims Portion of the Settlement Fund;

9 2. The number of points attributed to each eligible claimant under the Distribution
10 Formula are approved and awards from the Claims Portion of the Settlement Fund as set forth on
11 Exhibit 5 to the July 16, 2009 Declaration of Mara R. Thompson shall be issued to the claimants
12 in the amounts indicated on that exhibit;

13 3. Claim Forms referenced at Nos. 1-52 on Exhibit 2 to the July 16, 2009
14 Declaration of Mara R. Thompson are hereby accepted and determined to be eligible to receive
15 minimum awards of \$200 each.

16 4. Claim Forms referenced at Nos. 1-10 on Exhibit 3 to the July 16, 2009
17 Declaration of Mara R. Thompson are hereby accepted and determined to be eligible to
18 participate in the distribution from the Claims Portion of the Settlement Fund in the amounts set
19 forth on Exhibit 5 to the July 16, 2009 Declaration of Mara R. Thompson.

20 5. Claim Forms referenced at Nos. 11-15 on Exhibit 3 and at Nos. 1-24 on Exhibit 4
21 to the July 16, 2009 Declaration of Mara R. Thompson are hereby determined to be ineligible for
22 any award from the Claims Portion of the Settlement Fund;


23 6. Exhibits 2, 3, 4 and 5 to the July 16, 2009 Declaration of Mara R. Thompson shall
